Chinasoft’s “JointForce” has signed a Strategic Cooperation Agreement with Nanjing Turing Institute of Artificial Intelligence leading the industry intelligence upgrade

This announcement is issued by Chinasoft International Limited (the “Company”) as a voluntary announcement to allow the public to understand the latest information on the Company.

The Company is pleased to announce that its wholly-owned subsidiary, JointForce Network Technology Co., Ltd. has signed a strategic cooperation agreement with the Nanjing Turing Institute of Artificial Intelligence. In the future, both parties will give full play to their respective advantages and jointly construct the JointForce-Turing Institute, and carry out joint innovations in digital cities, smart manufacturing, financial technology and other fields, promote the process of artificial intelligence technology productization, and lead the upgrading of industrial intelligence.

Nanjing Turing Institute of Artificial Intelligence is a new type of research and development institution jointly established by Nanjing government and academician Yao Qizhi, the top scientists in the field of computer science around the world, the only Chinese ethnic winner of the highest award in computer science, Turing award, and the dean of the Institute of Cross-Informatics of Tsinghua University. The institution promotes technological innovation and achievement transformation in the field of artificial intelligence relying on the scientific and technological advantages of the Institute of Cross-Informatics of Tsinghua University. In the digital transformation of the service industry, the Company has accumulated a large number of application scenarios, the “JointForce” platform brings together software professionals from China and the world and has a strong IT industry integration capability. The two parties have joined forces to open a new chapter in cooperation between the new type of R&D institutions and leading enterprises in Nanjing, the headquarter of “JointForce”.

In the field of digital cities, the two parties will jointly build “Digital Twins Nanjing”, an artificial intelligence core model and application dedicated to government services and decision-making.
